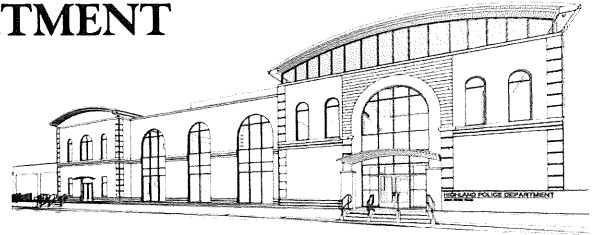

## HIGHLAND POLICE COMMISSION MEETING

March 11, 2021

The Highland Police Commission met in regular session. Commissioner Jurczak called the meeting to order at 7:00 P.M., followed by the Pledge of Allegiance.

Roll Call: Commissioner Danko, Krooswyk and Moes, were present. Chief Hojnicky . Councilman Herak were also present. Commissioner Slagle was absent with prior notice. Attorney Reed's presence was not required but was available by telephone should the need arise.

There were no public comments.

Minutes of the February 11, 2021 meeting were approved.

Approval was given to forward claims to the Town Council for payment.

On a motion by Commissioner Moes and seconded by Commissioner Krooswyk the Commission on a viva voce vote, amended the agenda to include the election/nomination of Police Commission Officers, Attorney and Recording Secretary.

### Appointments

Commissioner Jurczak made a nomination for the 2021 Police Commission Slate as follows: Commissioner Moes for Chairman, Commissioner Slagle for Vice Chairman and Commissioner Jurczak for Secretary with a second from Commissioner Moes. On a viva voce vote the Police Commissioner approved the listed appointments for the 2021 Police Commission slate. The appointment for the Police Commission Attorney was tabled. On a motion by Commissioner Danko and a second from Commissioner Krooswyk, the Police Commission on a viva voce vote reappointed LuAnn Stirling as Recording Secretary.

### Training

On a motion by Commissioner Danko and seconded by Commissioner Jurczak the Commission on a viva voce vote, approved the following training: Patrol Rifle Carbine Instructor- April 26-30, 2021- Plainfield, IN- Corporal Yonkman- Registration- \$475; Lodging- \$500 (1 rm 5 nights @ \$88 per day + tax); Per Diem- \$360-(6days@ \$60 per day); Mileage- Dept Vehicle.

On a motion by Commissioner Krooswyk and seconded by Commissioner Danko the Commission on a viva voce vote approved the promotion of Officer Tyler Dills to 1<sup>st</sup> Class Patrolman to be effective March 11, 2021.
