The Highland Economic Development Commission was established on duly 10, 2006, by Town Counciliordinance #1324. The first organizational meeting of the Commission was on January 31, 2007, at which time officers were elected and information was provided on the purpose and function of the Commission. A subsequent meeting was held on May 20, 2007, to

designate an Economic Development Target Area that was co-terminus with the Highland Redevelopment Area. The Highland Town Council on May 14, 2007, had already designated the Redevelopment Area as an Economic Revitalization Area with Resolution #2007-23. On March 28, 2008, the Highland Economic Development Commission met to designate 2609 45th Street as an Economic Development Target Area and to approve the minutes of May 20, 2007, and the annual report of 2007. The Commission dld not meet in 2009. In 2010, the EDC met on May 24, 2010 to discuss and approve the manutes of March 28, 2008 and the Annual Reports for 2008 and 2009, and to approve the following officers for the EDC: Matthew Reardon, President, George Vande Werken, Vice President, and David BeanBlossom, Secretary. The EDC also approved 2440 '45th St. as an Economic Development Target Area following a public hearing.
