The Twenty-Ninth Town Council of the Town of Highland, Lake County, Indiana met in its regular plenary session on Monday, April 25, 2022 at 6:30 O'clock P.M. in the regular place, the Highland Municipal Building, 3333 Ridge Road, Highland, Indiana.

*This meeting was convened as both an in person and an electronic meeting. Some persons were participating remotely on a Zoom platform that allowed for real time interaction, and supported the public's ability to observe and record the proceedings. People were able to participate in person and remotely. When the agenda item provided for public comment, this was supported as well. Councilor Bernie Zemen, Councilor Toya Smith, Councilor Mark Schocke, Councilor Roger Sheeman all participated in person.

Pursuant to HMC Section 2.05.130(A)(2), the Town Council considered and reviewed the agenda in an informal proceeding in the plenary meeting room before the president called the meeting to order.

The Town Council President Bernie Zemen presided. The Town Clerk-Treasurer, Mark Herak, was present to memorialize the proceedings. The meeting was opened with Councilor Bernie Zemen reciting the Pledge of Allegiance to the Flag of the United States of America and offering a prayer.

Roll Call: Present on roll call were Councilors Bernie Zemen, Toya Smith, Mark J. Schocke, Thomas Black, Roger Sheeman and Clerk-Treasurer, Mark Herak were present. A quorum was attained.

Additional Officials Present: John Reed, Attorney with Abrahamson, Reed & Bilse; Mark Knesek, Public Works Director (remotely); John Banasiak, Metropolitan Police Commander; William R. Timmer, Jr., CFOD, Fire Chief; Edward Dabrowski, Director of Information Technology; and Kenneth J. Mika, Building Commissioner; were present. Kathy DeGuilio-Fox, Redevelopment Director was on vacation; Alex M. Brown, CPRP, Superintendent of Parks and Recreation was welcoming his 1st grandchild born on Easter Sunday.

Also present: Larry Kondrat of the Board of Waterworks Directors.

Guests: Theresa Badovich (remotely) and Robin Carlascio (remotely) of the Idea Factory were also present.

Minutes of the Previous Meetings: The minutes of the April 11, 2022 meeting will be considered at the May 9th, meeting.

Special Orders: Town Council President Bernie Zemen read A Proclamation in Honor and Recognition of Rosemary Yuhasz on the occasion of her 100th Birthday on Wednesday, April 27, 2022.

Comments from the Public or Visitors:

1. Larry Kondrat, Highland, asked if the Council was finally done screwing around with the band situation for the 4th of July Festivities. We charged Mr. Herak, when he was a Councilman, to put this all together and now we want to play games when Mr. Herak was moved to the Clerk-Treasurer's Office and now we act as if we know nothing about bands. We had a fellow in here who was willing to do the contract but he turned into a giant whiner and he stormed out of here. He refused to contact Mr. Herak. Take the vote and be done with it. President Zemen responded that hopefully that happens tonight.

Mr. Kondrat also questioned the mums. The mums, really. We have a contract here to sign and we want to fiddle around with mums. You are going to sign a contract, then amend the contract to add \$3,000, which is approximately 10% of the contract to add mums. Mums are an interesting flower. The flower of the embezzlers. You had a fellow who was selling mums for Pop Warner football, he abscounded with the funds. Suddenly the mums become the most important plant on the planet to one of our Councilman. Let's go ahead and doing the planting and leave the mums out of it. It leaves a bad taste in a lot of people's mouths. He got away with \$12,000. Leave the mums alone. AN ORDINANCE TO AMEND CHAPTER 2.50 OF THE HIGHLAND MUNICIPAL CODE REGARDING THE PUBLIC RECORDS MANAGEMENT, FEE SCHEDULE – DOCUMENT REPRODUCTION CERTIFICATION, PURSUANT TO I.C. 36-1-5 AND I.C. 5-14-3 ET SEQ.

- **WHEREAS**, Title 36, Article 1, Chapter 5 of the Indiana Code provides that the legislative body of a unit **shall** codify, revise, rearrange, or compile the ordinances of the unit into a complete, simplified code excluding formal parts of the ordinances;
- **WHEREAS**, The legislative body of this unit, the Town of Highland, is the Town Council, pursuant to IC 36-1-2-9(5) and IC 36-5-2-2;
- **WHEREAS**, IC 5-14-3 specifically provides the policy for records access for all public agencies in Indiana;
- **W**HEREAS, The Town Council has previously adopted the provisions of IC 5-14-3, codified as Chapter 2.50 in the Highland Municipal Code;
- WHEREAS, The Highland Town Council has determined that the amendment of the Highland Municipal Code regarding its provisions dealing with records management, and in order to modify its existing FEES SCHEDULE DOCUMENT

- WHEREAS, The Highland Town Council, as the town legislative body, has been advised that is desirable to further modify the existing FEES SCHEDULE DOCUMENT REPRODUCTION CERTIFICATION of the Highland Municipal Code, Chapter 2.50.100 regarding its adopted changes of Ordinance 1863 to the Public Records Management Chapter would further perfect the municipal code by selectively adopting a new fee schedule; and
- WHEREAS, The Town Council of the Town of Highland, as the town legislative body, now desires to further modify the FEES SCHEDULE DOCUMENT REPRODUCTION- CERTIFICATION and fix such schedule based upon the needs of the Police Department, as is necessary and desirable to amend Chapter 2.50 in order to further improve and perfect the Code; and
- WHEREAS, The Town Council of the Town of Highland, as the town legislative body, has been advised, that information owned by a public agency or entrusted to it may charge a fee or fees uniform to all purchasers; and

WHEREAS, The Town Council of the Town of Highland, as the town legislative body, has determined that the new fee schedule does not exceed the sum of the agency's direct cost of supplying a duplicate of a computer disc or other storage medium containing a law enforcement recording and the fees to provide such information in that form will be applied uniformly to all purchasers; and

Now, Therefore, Be it hereby ordained by the Town Council of the Town of Highland, Lake County, Indiana, as follows:

1. That Subdivision (J) of Chapter 2.50.100 of the Highland Municipal Code is hereby repealed and shall be replaced by successor subdivision, which shall be identified and read as follows:

2.50.100 Fees schedule – Document reproduction – Certification.

(J) Notwithstanding any other provision of this chapter, when providing a duplicate of a computer tape, computer disc, microfilm, law enforcement audio recording, or similar or analogous record system containing information owned by the public agency or entrusted to it, a public agency may charge a fee or fees, uniform to all purchasers, that does not exceed the sum of the agency's direct cost of supplying the information in that form, provided that fee is approved in this

chapter. The following fees are hereby authorized and approved to be collected pursuant to this section:

1. Combined Media Fees, and electronic law enforcement video documents fee. For Law enforcement video recordings captured by an in-car camera, body camera, departmental lobby camera, departmental exterior camera, departmental interior camera or captured by a departmental booking camera will be provided for the sum of the recording base fee. Each individual incident recording will be charged as its own recording base fee.

Recording Base Fee: (includes the fee of the recording and the media device to which the recording will be downloaded and stored). \$125.00

Section 7. Whereas an emergency exists, and, therefore, this ordinance shall become and be in full force and effect from and after the adoption, passage and publication in the manner prescribed by law, until its subsequent amendment or repeal by proper ordinance, provided, any increase in fees described herein shall not go into effect until at least ninety (90) days following their publication pursuant to IC 5-3-1, as set forth in IC 36-5-2-10(d), and not sooner than provided in the amended schedules.

Introduced and Filed on the 25th day of April 2022. Consideration on First Reading was not considered pursuant to I.C. 36-5-2-9.8.

Commander Banasiak said this was the lowest number of applicants they have ever had. Commander Banasiak referenced the upcoming FOP Police Memorial to honor those officers killed in the line of duty, Officer Don Shepard and Officer Robert Markley. They also recognize those members of the FOP who have passed away. It is being held on May 7, 2022, at 9:00 in the morning, at Markley Park. Prior to the Memorial, the Police Commission will inspect the officers. Commander Banasiak encourage all to attend the Memorial.

Councilor Sheeman acknowledged the Fire Chief who said the Fire Department is moving on and the new secretary is working out great. He said he is working with NIRPC on a 90/10 grant to update the Opticom System. The process is in the early infancy stages. Chief Timmer explained how the Opticom System works. He said the new door are up at Central and what a world of difference it makes. Because the doors are clear, they are talking to the manufacturer of the doors if a device exists that the operator of the rigs will know when the doors are in the closed position, so no one drives through them.

Councilor Sheeman acknowledged Ed Dabrowski, the IT Director, who commented that all of the Town Council and Department heads have taken the test and he is now going to start to roll it out to the employees starting with the Police Department.
